## **Action Requested**

Provide direction and advice on development of a grant application to the ODOT Pedestrian and Bicycle Grants program for sidewalks on Logus Road.

## **Background**

ODOT has \$5 million in grant money available statewide for bicycle and pedestrian projects for Fiscal Years 2008 and 2009. Eligible projects include sidewalk infill, pedestrian crossings, intersection improvements, streetscapes, bike boulevards, and minor roadway widening for bikeways. The City received a \$190,000 grant from this program in 2002, which is contributing to the 42<sup>nd</sup> Ave Street/Stormwater improvement project.

The selection process is highly competitive; roughly one in five grants are funded. Grants over \$500,000 are uncommon. Projects to address the needs of school children, the elderly, the disabled, transit users or "others not well served by the current transportation system" are given special consideration, as are projects with innovative design features or that add to the "quality of experience" for non-motorized transportation users.

To identify the best project to advance for this grant, staff reviewed the eligible and currently "unfunded" projects listed in the Milwaukie Capital Improvement Plan (CIP). The City's School Trip Safety Program (STSP) identified several priority projects to improve the safety of pedestrian approaches to schools. Three of these projects are currently on the CIP as unfunded projects: Llewellyn Street & Franklin Street sidewalks;

Cedarcrest Drive sidewalks; and Logus Road sidewalks. Other projects listed in the CIP that would be eligible for these funds include improvements to the south side of Jefferson Street and 21<sup>st</sup> Ave. and Bluebird railroad crossing improvements. Staff feels that the STSP-identified projects deserve prioritization and are likely the most competitive type of project for this grant program.

Specifically, staff recommends pursuing funding for the Logus Road project. In addition to being identified by the STSP, Logus Road is a frequent service bus route with a narrow cross-section. Logus Road sidewalks were proposed by the City of Milwaukie in the last round of Community Development Block Grant (CDBG) funding. At that time, there was considerable excitement around the prospect of the project. County staff has indicated a willingness to utilize unexpended CDBG funds in Milwaukie for Logus Road sidewalk improvements, because the project remains CDBG-eligible.
