**Fugitive Attempts to Elude Police – Arrested After Vehicle Pursuit. Suspect Lodged at the Clackamas County Jail on Criminal Charges of: Unauthorized Use of Motor Vehicle, Two Felony Counts of Theft I, Possession of Controlled Substance – Methamphetamine, and Attempt to Elude.**

In the early morning hours of March 21, 2010, *Pacific Lumber* in the city of Lake Oswego felled victim to a vehicle theft, and the theft of \$1500 in power tools. The suspects stole a large truck with a flatbed trailer from inside the security fence of the lumber company.

A short time later, the stolen truck and trailer were driven to Milwaukie. Suspects cut the lock on the security fence of *Milwaukie Lumber*, at 10998 SE Main Street, Milwaukie, Oregon. After moving the stolen truck and trailer inside the fenced lumber yard, the suspects forced the ignition on a forklift, and used it to load the stolen truck and trailer with three pallets of wood siding products worth \$9500.

Within two days of the thefts, Milwaukie Police Detectives discovered that some of the stolen property was listed for sale on the Internet site *Craigslist*. Undercover, the detectives set up a buy of the stolen property at 1010 SE 148<sup>th</sup> Avenue in Portland. The detectives recovered \$6000 of the stolen property and arrested Michael Summers (date of birth 03-02-58) for an outstanding parole violation.

The investigation led detectives to additional stolen property at 3004 NE 160<sup>th</sup> Drive in Portland. A second suspect was identified as Zane Grey Macziewski (date of birth 07-14-65).

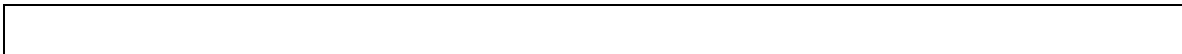
Macziewski was wanted at that time on an outstanding warrant from the state of Washington. Law enforcement continued the search to locate Mr. Macziewski.

On 04-20-10 Milwaukie police officers tried to initiate a traffic stop on a vehicle being driven by Zane Macziewski. Zane Macziewski refused to stop for police and attempted to elude. Police pursued the maroon colored car Macziewski was driving.

The pursuit began in Milwaukie and ended near the intersection of SE 82<sup>nd</sup> Avenue and SE Foster Road in Portland. Using the push-bumper of the patrol car, a Milwaukie police officer successfully stopped the suspect vehicle near the entrance to the Wells Fargo Bank parking lot. Other patrol cars were then able to surround the suspect vehicle, preventing it from moving. Portland Police assisted in taking Mr. Macziewski into custody.

Zane Macziewski was arrested for a Washington State fugitive warrant, a parole detainer warrant, Unauthorized Use of a Motor Vehicle, two counts of Theft I, and Possession of a Controlled Substance – Methamphetamine. He has been lodged in the Clackamas County Jail.

Mike Summers, the other suspect mentioned, remains in custody. A list of similar criminal charges is pending against Mike Summers.
